- the cargo tanks and spaces within the cargo area on board the SEAGOING TANKER, as indicated on the back side of this form, are loaded with a dangerous good with an exclusively flammable property with a flash point lower than 55°C or empty from such a dangerous good and have not been cleaned, whereby:
 - these spaces are not directly adjacent to the ship's hull; and,
 - the atmosphere contains a maximum of 8% oxygen or a maximum of 20% of the lower explosive limit (LEL).
- the cargo holds of the COMBINATION CARRIER contain no dangerous substances as liquid cargo or residue from such cargo and the slop tanks as indicated on the back side of this form contain or have contained flammable cargo residue, whereby:
 - the atmosphere contains a maximum of 8% oxygen or a maximum of 20% of the lower explosion limit (LEL); and,
 - the slop tanks are not directly adjacent to the cargo spaces; and,
 - all other spaces in the cargo area which do not contain flammable liquids or vapours with a flash point of 55°C or lower.
- neither of the above two options applies to this vessel.
